

COVID-19 VACCINE COUNSELING COVERAGE AND REIMBURSEMENT:

This communication serves to further clarify the updated Medicaid Guidance that was previously posted on the MetroPlusHealth website regarding COVID-19 Vaccine Counseling Coverage criteria and billing. Providers can bill MetroPlusHealth for COVID-19 vaccination counseling <u>for Medicaid</u>, <u>HIV SNP</u>, <u>and HARP members</u> to encourage the administration of the COVID-19 vaccine.

The following provider types may bill for COVID-19 vaccine counseling:

- √ Physicians
- ✓ Nurse Practitioners (NPs)
- ✓ Licensed Midwives
- √ Pharmacists*
- ✓ Article 28 clinics billing ordered ambulatory
- ✓ Federally Qualified Health Centers (FQHCs)
- ✓ Other qualified rate-based providers

Coverage Criteria

Qualified Providers may bill up to four (4) counseling visits <u>per</u> vaccine dose (up to 12 visits per member, annually):

- In addition to an Evaluation and Management (E&M) or Well Child Visit when all the regulatory criteria are met and documented.
- Whether or not a COVID-19 vaccine is administered during the session
- For <u>unvaccinated</u> Medicaid, HIV SNP, and HARP members, confirming that patient has not received the first or subsequent dose, including booster doses of the COVID-19 vaccine, <u>and</u> does not already have a scheduled appointment to receive the dose.
- Confirming the member's vaccination status in the New York State Immunization Information System (NYSIIS), whenever possible

✓ MetroPlusHealth

- Strongly recommending the vaccination (unless medically restricted, in which case, counseling session is not billable)
- For Children:
 - Using Medicaid enrollee's CIN when billing for counseling provided to a parent, caregiver, or guardian for the benefit of the child, with or without the child present during the counseling session.
 - Confirming patient consent of the parent, guardian, or caregiver (as appropriate)

Coding and Reimbursement:

- Qualified providers should bill using CPT Code 99429 for reimbursement of COVID-19 vaccine counseling sessions.
- Maximum reimbursement fee for COVID-19 counseling session is \$25.
